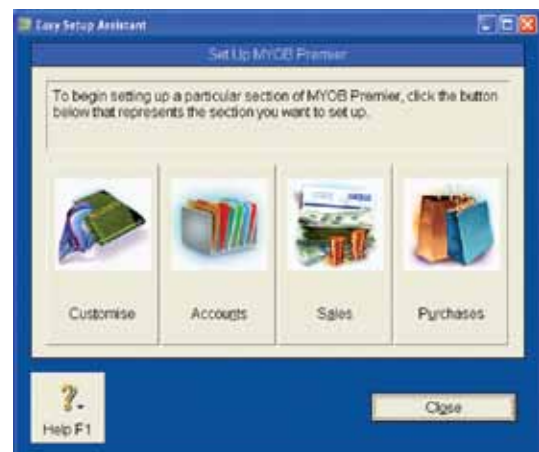

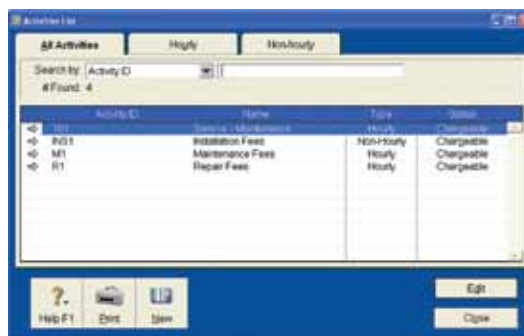

What are some of the Obligations of a Taxable Business?

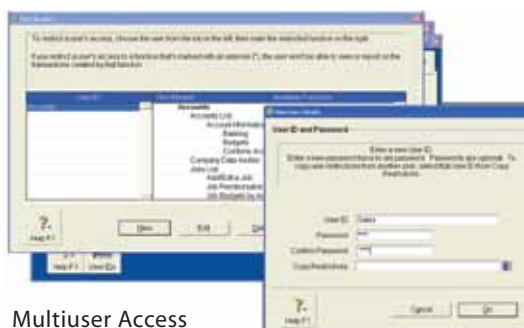
- a. Account for GST on taxable supplies made and received
- b. Submit GST return and pay tax by the due date
- c. Issue tax invoice on any taxable supply made unless as allowed by the Director General
- d. Keep adequate records of business transactions relating to GST in the national or English language for seven (7) years.

How can MYOB help you meet some of these obligations?

Obligation (A): Account for GST on taxable supplies made and received	MYOB keeps track of your Taxable Supplies from point of purchase, inventory to sales.
Obligation (B): Submit GST return and pay tax by the due date	MYOB generates a report that displays a list of transaction of Total Supplies, Total Taxable Purchases, Total Output Tax, Total Input Tax and Net GST within a prescribed GST period. You can also generate the GST 03 text file that can be uploaded to the RMCD's Taxpayer Access Point (TAP) Portal. This enables you to declare your tax information monthly or quarterly online. This makes it very easy for you to submit your returns at an interval appropriate for your business.
Obligation (C): Issue tax invoice on any taxable supply made unless as allowed by the Director General	MYOB provides predesigned tax invoice based on RMCD's requirements. You can customise your invoices to suit your company format. Please take note that tax invoice must be provided within 21 days of the supply being made. MYOB will simplify this process with a click of a button.
Obligation (D): Keep adequate records of business transactions relating to GST in the National or English language for seven (7) years.	MYOB's archival procedures are put in place to ensure the integrity and readability of electronic records after an extended period (maximum 7 years). There is a restoration mechanism to restore the archived data, verify that restoration process is complete and generate necessary reports from the restored data. MYOB tracks <ul style="list-style-type: none"> • your business and accounting records • copies of serially printed receipts, tax invoices and simplified invoices • all credit and debit notes and much more.

Additional Crucial information.

- MYOB GST Approved Products can generate the GST Audit File (GAF) in text file format. The GAF text file is generated for the selected time period and this file conforms to Royal Malaysian Customs Department's (RMCD's) requirements.
- MYOB generates quotes that show GST inclusive amounts for both goods supplied and services rendered.
- You can include GST registration in MYOB generated tax invoices, simplified tax invoices and receipts.

What is a GAF file and why is it important to my business?

Royal Malaysian Customs Department (RMCD) conducts periodic Audits to ensure that tax returns are prepared correctly. It is crucial that the detailed information transmitted between RMCD and the business is complete, accurate and in a format that is readable by RMCD. The GST Audit File generates the necessary information required by RMCD to conduct this periodic audit.
